

DEMAND was established in 1980, following a decade of development in the designing and making of equipment for disability at the London College of Furniture.

Chairman's Message

The first phase of our development has been completed by the opening of the DEMAND workshop at 99 Leman Street on 23rd May, 1983 by our Patron, Esther Rantzen; but that was essentially "groundwork" and we can now look towards our main and permanent task, which will steadily increase. It is to engage in research, design and the making of special equipment for disabled people, and to fund bursaries for students who are being trained for this work.

Although we continue to rely on the help of staff and students at the London College of Furniture, we now have the advantage of our own full-time manager and his assistant, working in our own workshop and administrative office. Our students are taking a CNAA Postgraduate Course which is *THE ONLY ONE IN EXISTENCE FOR SPECIALIST DESIGNERS IN THIS FIELD*.

All of this work requires ever increasing funds to pay for, among other things, salaries, materials, travel expenses and the monitoring and testing of equipment, even though we are able to save administrative costs through some people generously giving their time and effort voluntarily.

The progress made in our first three years has been due to a great team effort by people who are determined to help the disabled in the ways we are doing. I would like to express my thanks to the members of the Committee for their loyalty and hard work, and to Mr. and Mrs. Dominic Le Foe — who organised a splendid St. Valentine's Evening at the Players' Theatre, which raised £3,000 for DEMAND. We are greatly indebted to Mr. Paul Lucas for presenting us with all the furniture needed for our new offices and to the Epson Corporation for the gift of their latest desk-top microcomputer to assist our research. The British Petroleum Company has most generously presented us with a specially adapted vehicle for use as an ambulance, so that patients from a distance may be brought to our workshop for fitting and testing equipment, and to enable students and their instructors to visit patients in hospital or at home.

We are deeply grateful to the Bucklebury Trust for their magnificent contribution towards the setting-up of the workshop and to Marks & Spencer and the Sir Jules Thorn Trust, who demonstrated their faith in our Course by again providing funds for students' bursaries in 1983. To all who have contributed with gifts or by their services I would like to express our immense gratitude.

Annual Report

As we forecast in our last Report a major part of our work during 1983 has been to expand our capacity to design and make equipment and environments for people of all ages with a range of disabilities.

We now have a well equipped basic workshop with a design studio and offices, and a van fitted to serve both as an ambulance and for general transport.

Design and making

These facilities can now supplement the sophisticated resources of the London College of Furniture and greatly increase our ability to produce special equipment that cannot be undertaken within the educational programme.

Despite the heavy demands made upon them by the fitting and equipping of the workshop and offices, our workshop manager Eric Barnes and our designer Brian McKee have delivered a substantial amount of equipment to people in need and the programme is growing with the help of craftsmen David Gold and Walter Crouchman.

Research

The MA programme of research into seating for geriatric patients conducted by Miss Ruth Dunstone is at an advanced stage.

Brian McKee is continuing research and development of the domestic wheelchair, sponsored by the Hans Arndt Trust.

The College is undertaking major research, sponsored by the Department of Industry, to develop a computer-controlled shaping of expanded foam materials to reproduce the contours of the human form. This would provide a swifter, cheaper alternative to the present method of shaping shells for handicapped people in plastic reinforced glass fibre.

The Postgraduate Course in Design of Equipment for Disability

The third one year course commenced in September with an enrolment of 11.

Demand is providing scholarships to assist four students.

New Projects to be undertaken within the course this year include:

Collaboration with British Aerospace in the development of a wheelchair to climb stairs – with a special emphasis on safety, posture and comfort in seating.

A table (in association with the Richard Cloudesley School) to help the chair-bound in computer studies.

A recliner for paraplegics. The design will assist safe transfer from wheelchair to recliner.

Prone board for children - a redesign in lightweight metal.

A system for the conversion of rooms at Bolingbroke Hospital.

This will facilitate the adaption of hospital rooms as a more "home-like" base for the long term geriatric patients.

A natal delivery chair – in association with Queen Mary's Hospital, Croydon. This project will improve on existing designs and greatly reduce the cost.

Administration

With the establishment of the new offices in Leman Street, we have been greatly strengthened by the appointments of Julian Ross as Honorary Administrative Director, Mrs Joan Carr as Finance officer and Mrs Anne Hooper as Clerical Assistant. We are particulary gratified that a large part of administrative work continues on a voluntary basis


Financial Report 1983

Expenditure was just over £56,000. Capital expenditure on the new workshop and offices of nearly £29,000, net of depreciation, will not recur at this level.

Funding




The Cheyne Standing aid is designed for children with severe postural problems. A project in collaboration with the Cheyne Centre






